THIS FIRST AMENDMENT TO SUPPLEMENTARY DECLARATION is made this <u>8th</u> day of <u>July</u>, 1980, by WARMINGTON DEVELOPMENT, INC., ("Declarant"), with reference to the following facts and circumstances.

RECITALS:

- A. Declarant executed a Declaration of Covenants, Conditions and Restrictions which was recorded in Book 13022, Pages 984 through 1065, inclusive, of Official Records of Orange County, California (the "Declaration"), covering real property in the City of Yorba Linda, County of Orange, State of California, described as Tract No. 9953, as per Map recorded in Book 418, Pages 24 to 26, of Miscellaneous Maps, Records of Orange County ("Phase 1 of the Project");
- B. Declarant executed a Supplementary Declaration of Covenants, Conditions and Restrictions and Declaration of Annexation for Tract No. 9955 (the "Supplementary Declaration") which was recorded in Book 13588, Pages 1550 through 1557, of Official Records covering real property in the City of Yorba Linda, County of Orange, State of California described as Tract No. 9955, as per Map recorded in Book 424, Pages 44 through 46, inclusive, of Miscellaneous Maps, Official Records of Orange County ("Phase 2 of the Project").

C. Declarant now desires to amend the Supplementary Declaration.

NOW, THEREFORE, Declarant hereby amends the Supplementary Declaration by adding thereto Article VI as follows:

VI

DRIVEWAY EASEMENTS

There is hereby created driveway easements as shown on Exhibit "A" attached hereto, which easements shall be appurtenant to the lots described on said Exhibit as "Dominant Tenement", and which easement shall burden the lots described on said Exhibit as "Servient Tenement". Said easements shall be in favor of the Dominant Tenement over the Servient Tenement for purposes of ingress and egress. The easement area on each affected lot shall be maintained by the owner of the lot.

Except as modified by this First Amendment to Supplementary Declaration, the Declaration and Supplementary Declaration ation shall remain in full force and effect.
